WHEREAS, for the past several years, the Village has been working closely with representatives of Federal Express in order to obtain all governmental and regulatory authority necessary to install traffic signalization at 49th and Central (the "Project"); and

WHEREAS, the President and Board of Trustees have determined that the implementation of the Project is in the public interest of the Village as well as traffic safety; and

WHEREAS, as a result of various efforts, the General Assembly has passed Senate Bill 1734, which authorizes the Village to initiate what is commonly referred to as "Quick Take" eminent domain litigation proceedings "for the purpose of installing a traffic signal at the intersection of 49th Street and Central Avenue;" and

WHEREAS, in addition to pursuing the Quick Take litigation, it is necessary for the Village to obtain regulatory approval from the Illinois Commerce Commission; and

WHEREAS, the President and Board of Trustees have determined that it is reasonable to appoint special lead counsel to represent the Village in the proceedings attendant to the acquisition of all entitlements necessary to complete the Project;

NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW AS FOLLOWS:
