**WHEREAS**, the Central Regional Council of Mayors has solicited various municipalities to submit applications for federal funding of roadway rehabilitation improvements; and

**WHEREAS**, the Village of Forest view is under the jurisdiction of the Central Regional Council of Mayors, and is therefore eligible to submit such an application; and

**WHEREAS**, the President and Board of Trustees of the Village of Forest View desire to submit an application for roadway improvements within the following areas: 46<sup>th</sup> Street from Harlem Avenue to Oak Park Avenue.

**WHEREAS**, federal funding through the Surface Transportation Program is available for such roadway improvements at the rate of eighty percent (80%) federal dollars for the costs of construction and construction engineering costs, with a twenty percent (20%) local match; and

**WHEREAS**, the Village President and Board of Trustees find the submittal of an application seeking federal funding of roadway improvements on 46<sup>th</sup> Street from Harlem Avenue to Oak Park Avenue to be in furtherance of the health, safety and welfare of, and in the best interests of, the residents and property owners within the Village of Forest view.

**NOW, THEREFORE, BE IT RESOLVED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF FOREST VIEW AS FOLLOWS:**

**SECTION 1:** The above recitals are incorporated by reference.

**SECTION 2:** The Village President and Board of Trustees of the Village of Forest view (the “Village”) authorize Edwin Hancock Engineering Company (Village Engineer) to prepare an application seeking funding for roadway improvements within the following areas: 46<sup>th</sup> Street from Harlem Avenue to Oak Park Avenue, and to submit such application, on behalf of the Village, to the Central Regional Council of Mayors. The Village President and Village Clerk, or their designees, are directed and authorized to execute the application, and to execute and deliver all other instruments and documents that are necessary in order to apply for funding for roadway improvements within the Roadway Project Boundaries.

**SECTION 3:** If funding for the roadway improvements is approved, the Village President and Board of Trustees of the Village of Forest View agree to appropriate and approve the expenditure of sufficient funds to finance its proportionate local share of the improvements at the appropriate time.

**SECTION 4:** The Village Clerk, or her designee, shall transmit a certified copy of this Resolution to the Central Regional Council of Mayors for record retention purposes.

**SECTION 5:** This Resolution shall be in full force and effect from and after its adoption and approval in the manner provided by law.
