# AN ORDINANCE AMENDING SECTION 9-2-6 OF THE FOREST VIEW VILLAGE CODE TO ELIMINATE THE RESIDENT-ONLY PARKING RESTRICTION ON THE 4500 BLOCK OF WENONAH AVENUE

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Forest View, Illinois as follows:

**SECTION 1: Amendment:** Section 9-2-6 of the Forest View Village Code, "Designating Residents-Only Parking on Certain Streets," is hereby amended to provide as follows: [Repealed language indicated with strikeout]:

### 9-2-6: DESIGNATING RESIDENTS ONLY PARKING ON CERTAIN STREETS:

It shall be unlawful for any person other than a village resident to stop, stand or park a motor vehicle at any time on the following designated streets or portions thereof, within the corporate limits of the village:

On the east side of the 4500 block of Clinton Avenue except from the north right-of-way line of 46th Street on the south to a point twenty feet (20') north of the north right-of-way line of 46th Street.

On the west side of the 4500 block of Clinton Avenue.

On the east side of the 4500 block of Home Avenue except the following: From the entrance to the driveway of the property commonly known as 4507 S. Home on the north to the entrance of the driveway of the property commonly known as 4513 S. Home on the south.

From the north right-of-way line of 46th Street on the south to a point forty feet (40') north of the north right-of-way line of 46th Street.

On the east side of the 4500 block of Wenonah Avenue except from the north rightof-way line of 46th Street on the south to the north entrance of the municipal parking lot on the north.

On the west side of the 4500 block of Wenonah Avenue.

On the east side of the 4600 block of Clinton Avenue.

On the east side of the 4600 block of Wenonah Avenue except from the entrance to the driveway of the property commonly known as the park district garage on the south to the entrance to the driveway of the property commonly known as 4619 S. Wenonah on the north.

On the west side of the 4600 block of Wenonah Avenue except from the north right-of-way line of the joint fee strip on the south to the entrance to the driveway of the property commonly known as 4626 S. Wenonah on the north.

On the west side of the 4600 block of Clinton from a point twenty feet (20') south of the south right-of-way line of 46th Street on the north to a point one hundred feet (100') north of the north right-of-way line of the joint fee strip on the south between the hours of eight o'clock (8:00) A.M. and nine thirty o'clock (9:30) P.M.

**SECTION 2:** Effective Date. This Ordinance shall go into effect on immediately upon its passage.
